

# STOP INFANTICIDE, VOTE PRO-LIFE PETITION

**Whereas**, Senators Kaine (D-VA) and Warner (D-VA) oppose the Born-Alive Abortion Survivors Protection Act in the United States Senate; and

**Whereas**, Governor Northam (D-VA) appeared on a radio program in 2019 and, when defending Delegate Tran’s (D-42) Bill, HB 2491, to eliminate all meaningful restrictions on abortions up to birth, endorsed doctors letting babies die without care after they have been born; and

**Whereas**, there is substantial support among pro-abortion members of the Virginia General Assembly for multiple bills introduced in the 2020 Session to eliminate all meaningful restrictions on abortion throughout pregnancy up to birth, including Virginia’s Parental Consent law and Ultrasound law, and

**Whereas**, New York, Vermont, and other states have recently passed laws to eliminate all restrictions on abortion up to birth; and pro-abortion activists in the General Assembly want to pass an amendment making abortion a right under the Virginia Constitution, and

**Therefore**, be it resolved, that we the undersigned, Oppose Infanticide; Support the Born-Alive Abortion Survivors Protection Act; Support the Pain-Capable Unborn Child Protection Act; Support the Unborn Child Protection from Dismemberment Abortion Act; and Oppose adding the Right to Abortion to the Virginia Constitution and that we the pro-life voters of Virginia INSIST all elected officials in Federal, State, and Local office vote FOR laws that STOP infanticide and abortion.
