“FUNDAMENTAL RIGHT TO REPRODUCTIVE FREEDOM”

“PROVIDES THAT EVERY INDIVIDUAL HAS THE FUNDAMENTAL RIGHT TO REPRODUCTIVE FREEDOM AND THAT SUCH RIGHT SHALL NOT BE DENIED, BURDENED, OR INFRINGED UPON UNLESS JUSTIFIED BY A COMPELLING STATE INTEREST, DEFINED WITHIN THE TEXT OF THE AMENDMENT, AND ACHIEVED BY THE LEAST RESTRICTIVE MEANS.

THE AMENDMENT ALLOWS THE COMMONWEALTH TO REGULATE THE PROVISION OF ABORTION CARE IN THE THIRD TRIMESTER WHEN IT IS MEDICALLY INDICATED TO PROTECT THE LIFE OR HEALTH OF THE PREGNANT INDIVIDUAL OR WHEN THE FETUS IS NOT VIABLE.

THE AMENDMENT PROHIBITS THE COMMONWEALTH FROM PENALIZING, PROSECUTING, OR TAKING ADVERSE ACTION AGAINST AN INDIVIDUAL FOR EXERCISING THE INDIVIDUAL'S RIGHT TO REPRODUCTIVE FREEDOM OR FOR AIDING ANOTHER INDIVIDUAL IN THE EXERCISE OF SUCH RIGHT.”

VIRGINIA ABORTION- UNTIL-BIRTH CONSTITUTIONAL AMENDMENT ROADMAP

1ST STEP TO AMEND VIRGINIA'S CONSTITUTION WAS TAKEN

January 2025:

1. The Amendment was approved by both the House and Senate in the Virginia General Assembly.
1. The language in the bill cannot be altered after this vote.

Fall 2025 Elections:

1. An Election is required before the Amendment can be voted on again by Virginia House of Delegates.

STEP 2: IN THE PROCESS

STEP 3: TO CHANGE THE VA CONSTITUTION TAKES PLACE

January 2026:

1. The Amendment is introduced again in both the VA House & Senate and must pass both chambers.
2. Virginia Law prohibits a Governor's veto on constitutional matters.

FINAL STEP: THE AMMENDMENT IS PUT ON THE BALLOT

Fall 2026 Elections:

1. IF the Bill passes both the House and Senate for a second time, it goes to a ballot.
2. Measure is put on ballot: People vote yes/no to change the Virginia Constitution.
